RELEASE OF LIABILITY

In consideration of the acceptance of my application to become a member of the Maine Schutzhund Club, I hereby waive, release and discharge any and all claims for damages for death, personal injury or property damage which I may have or which may subsequently occur to me as a result of my participation in any Maine Schutzhund Club events, including training.

This Release is intended to discharge in advance the club officers, promoters, sponsors, officials, land owners, other club members, participants, and the United Schutzhund Clubs of America from and against any and all liability arising out of or connected in any way with my participation in any club events, even though that liability may arise out of negligence or carelessness on the part of the person or entities above mentioned.

I am aware that Maine Schutzhund Club events include training and trials of various breeds of dogs. I am familiar with such training. I am aware that injury and damage can occur in such club events, including training, both to myself and any dog(s) I have. Knowing the risks, I hereby agree to assume those risks and to release and hold harmless all of the person or entities mentioned above who, might otherwise be liable to me or my heirs and assigns for damages.
